#### CODE ENFORCEMENT UPDATE

Our June guest speaker was Lauren Due. Lauren is the Code Enforcement office for the SNI area of Sherman Oaks Neighborhood Association.

Lauren distributed informational flyers and explained that Code Enforcement is a complaint driven office. They respond to complaints, but don't go looking for violations for the most part. Lauren does, however, drive through the neighborhood once a week and his team conducts driveway sweeps of the whole area periodically. Our next sweep is due in July.

The mission of Code Enforcement is to work in partnership with people to promote and maintain a safe and desirable living and working environment.

Among the regulations they enforce are those pertaining to graffiti, weeds, zoning requirements, San Jose Municipal Housing Code (minimum standards for safe and sanitary housing), building code violations and blight. In short, anything that could affect living and working conditions.

Officers respond to citizen complaints on a confidential basis but you can ask for follow up on your complaint. Code Enforcement notifies the offender in writing and sets a deadline. The office tries to help remedy the situation but does have the authority to cite and use the judicial system if necessary.

In the SNI project area there are also driveway "sweeps" where staff drives the entire neighborhood to look for obvious violations. Lauren commented that this is a pretty clean neighborhood overall. The majority of letters sent out to residents concerned the storage of trash and recycling containers in view of the street.
