## Notes From the President

Next month will be our 100th issue of the SONA newsletter! What a milestone for us! And a time to remind ourselves of who we are and what our goals are. SONA is a neighborhood organization that was founded to bring together residents living in an area bounded by the Los Gatos Creek, along Bascom Avenue to Hwy 280 at Meridian and back over to the creek trail. A large area, one with fewer stores and services than 10 years ago, but one with the potential to see huge growth in the next 20 years. SONA residents, businesses and other organizations work to make our area a great place to live, work and play. Our all volunteer army works to build relationships between neighbors, businesses, government, service organizations and other neighborhoods throughout our district and the city. We provided a soccer team with uniforms, have conducted numerous clean up days, and have helped reduce crime, graffiti and vandalism in our neighborhood, planted trees, come together on issues and enjoyed potlucks.

Our next meeting will be devoted to organizing efforts around San Jose City College (SJCC) and partnering with our neighbors on these issues. We have received support from Willow Glen, Shasta Hanchett/Park, Buena Vista and others. We are inviting them to our meeting and hope to have people from all these neighborhoods as well as the Burbank and Pamilar neighborhoods. It's time to have a group discussion and make sure everyone is aware of all our efforts and to ensure that problems aren't just pushed from one side of the campus to another. We also need all the documentation that you have stashed around your house so we can compile a complete file. We have discovered that many of you have emails or correspondence that others don't. If you can scan and send them to a board member, great, if not bring your documents to the meeting. We promise we'll return your originals.

On June 2 at 7pm a study session with the Board of Trustees will be held in room T-415 at San Jose City College. While comments for the SDEIR are closed, the Board is holding this session to discuss comments on the Baseball Field Complex only. This does not re-open public comment but will allow the Board to hear your statements. This is an unusual step but it will allow the residents to talk about the fact we were told one thing while another thing was being developed. You can also expect to hear from the baseball players and families that night.

Steve Kline received documents just before press time that will allow us to look at how the process of moving projects forward worked. While we seem to have the support of the trustees, many people would like to know where the failures were and how we can ensure they don't happen again.

There are some very important "Do not miss" meetings coming up, so please go to page 3 and make sure you don't miss them. We will need people to attend various meetings regarding SJCC, so please make sure that your name is either on a petition or contact Steve Kline, Michael LaRocca or Randi Kinman. We go to press before meeting agendas are posted so we need to develop a list of interested people.

The Bascom Avenue Library and Community Center walls are going up! The first wall was installed on Wednesday, 5/27 and the remaining walls will be staged in 6-8 week intervals. The work will move from the Bascom side to the Del Mar side and is quite the production to watch. There is a safe zone that allows interested parties to view the event. While exciting to watch, it is still sad that our center will not be opened upon completion due to the city's current budget mess. ## Notes and News

Thanks to our new and renewing members this month: **Stan Paddock** not only became a member, he helped pay for our website! We currently have 264 dues paying members representing 167 households and one non-profit. These dues and donations are essential for our operations.

At \$250 per month, our newsletter is our major expenditure. SONA could generate revenue from ad placement, but our volunteers are stretched pretty thin. St. Elizabeth park is going through the final process of being developed. The original agreement was that a portion of the land for the park would be used for a sales office for the St. Elizabeth development. Residents have noted the sales trailer being jacked up to be moved. The park will be completed by the developer prior to being turned over to the city. It must meet inspection criteria and be approved for transfer by the council which could take another couple of months. The tentative "we can use it" date is September 2009. By that time all grass and landscaping should have time to "set" before being used; if not the park will remain closed until it can handle high traffic. So, it's taken awhile, but we are on track to have a party at our new park sometime soon.

Some residents on the south side of San Jose City College are now celebrating a new buffer between their houses and the campus. After almost a decade of talk and many revisions, a modified wall was put into place in May.

Yeah for more trees! There are some wonderful new trees along Leigh Avenue beginning at Fruitdale that will provide much needed shade for pedestrians and users of public transit. The trees were planted along the fence line of the property used by the Parkway Child Development Center which is technically Campbell Unified School District property. Each piece of green helps!

The City of San Jose has mandated watering restrictions, so re-set any automatic timers you are using for lawn care. Help avoid rationing by watering only between 6pm and 8am. By watering only during these hours, you will lose less water to evaporation and lower your water bills.

The annual notification of property taxes will arrive in June. This notice will advise you of your home assessment for the tax year 2009-2010. It will not change the amount of taxes currently owed. If you feel that your home is valued lower than your assessment, you can file a formal request for review with the Assessor's office between July 2-Sept 15. While the assessment is free, a \$30 processing fee is required for each application. Do not fall for scams that ask you to pay for this free service. ## San Jose City College

The Board of Trustees met on May 12 in both open forum and closed session. Prior to the closed session, President Randi Kinman appeared before the Trustees to thank them for slowing the process of certifying the SDEIR until all questions were answered. Kinman also advised them that SONA residents and others would like to work with them on resolving issues and suggested a study session to bring all parties to the table.

During open session the Trustees decided to have an open session but couldn't come to a decision on a date. While they hoped to complete this task prior to their June meeting, as of press time there is no date set.

SONA board members Michael LaRocca and Steve Kline joined Kinman at the Trustees open session held in the auditorium. This turned out to be a very vigorous meeting because, for the first time ever, the district is looking at layoffs. With the current budget crisis comes severe cuts to funding for basic programming. Many students were there to state the campus is a life line to developing job skills. Because many students are very low income, there is concern that raising fees will push them past the point of being able to attend.

Steve Kline spoke during open session and presented a Freedom of Information Request regarding expenditure of bond funds. Steve has been unable to obtain a complete accounting of how bond money has been spent during the build out of new campus facilities.

All the board members spoke on an agenda item that would have raised daily parking fees 50% from \$2 to \$3. Staff had brought the proposal forward in response to a request to search out ways to generate much needed revenue. The increase in fees would have brought about \$55,000 to the general fund. Board members pointed out that raising fees would most likely be a tipping point for students who would save money by parking on city streets. Trustees were advised of the high rate of crime that residents and students endured when on street parking was at it's highest level as well as the existing permit parking on the south side of the campus and the number of cars currently using city streets. Board members asked that the campus conduct a parking survey prior to implementing a fee increase, another after a fee increase, commit to paying for permit parking if needed by residents and prioritizing construction of a second parking facility. The Trustees discussed the issue and the motion to raise fees was withdrawn.
