Notes and News

You may have noticed detour signs and marks on the pavement along Hwy 280. Caltrans received funds to install freeway metering lights along Hwy 280 from Bascom to the 10th/11th Street exits. Allowing cars to ease onto the freeway instead of the rugby scrum we currently see will prevent stop and go traffic on the freeway and reduce the amount of exhaust that we get in the neighborhood. Board member Randi Kinman discovered that the meters on Moorpark were scheduled to be set at the corner of Menker Avenue. Concerned about the affect this would have on surface streets she reached out and eventually got a meeting with Caltrans, VTA and San Jose's Department of Transportation and outlined the problems that would be created. Through a series of emails she discovered there is an option to move the meter farther down the ramp where traffic naturally comes to a standstill when exiting freeway traffic is crossing with entering traffic. The issue is convincing Caltrans to do so. If you are interested in helping by attending meetings or talking with staff or elected officials, let Randi know (see below for contact info). Friends of Bascom on the Move

With the impending completion of the Bascom Community Center and Library, residents have formed a "**Friends of Bascom Library**" group. Friends groups can be found at all of our libraries, sponsoring events, raising funds for programs and volunteering their time. This partnership helps cut costs at each branch by allowing residents to become involved in book sales, bake sales and other efforts that augment the City's budget.

By developing close community relationships, our libraries become a strong part of our community. Children know their local librarian by name, families participate in a wide range of programs, job seekers have friendly staff to help them on in-house computers and students find assistance during study times or tutoring sessions.



Libraries are a key component in the development of a safe and prosperous neighborhood, so it's no wonder that the first "*Friends of Bascom Library*" meeting drew dozens of residents. Thanks to the use of a large room at our new Vietnamese restaurant on Bascom Avenue, Com Tam Than, SONA residents and others were able to get together and discuss how we can join with our library staff. Board member Steve Kline and former board member Susan Price-Jang are leading this charge.

Unlike other libraries, our Friends group is faced with a big hurdle coming out of the gate: The City of San Jose is renegeing on promises to open this library when it is completed. During the search for a site and the development of plans for the Bascom Community Center and Library, residents were assured that our facility would open when completed. Citizens who sat on the development team (Randi Kinman, Susan Price-Jang and Michael LaRocca) asked repeatedly about the ongoing cutbacks and were repeatedly promised that all sites would be open. As long as eight years ago it was obvious that the economic situation would not get better, would in fact get worse, and residents were told that the pain of budget cutbacks would be shared. If opening all facilities meant they would only be open part time, that was what was supposed to happen. It has only been recent (in terms of the length of this process) that we were told there was a possibility the site would not open at all once complete.

The Bascom site is due for completion in just a few months, Fall 2010. There are currently no plans or proposals to open the site for at least a year (2010-2011 cycle) and no guarantee that it would open with the next (2011-2012) budget cycle. Our budget cycles begin on July 1. There has been no proposal made to put the site on a contingency list, allowing it to open if money is found outside the current budget. The *Friends of Bascom* are actively lobbying to change this. Along with the Seven Trees branch, the Friends want all libraries opened, including Bascom on 1/1/11. This means intensive work to convince City Council members to do the right thing and keep promises. Because there is no current intention to open for 2010-2011, library staff have not been allowed to start purchasing materials (books, furniture, computers) that take months to arrive. If not ordered, then that is another excuse to not open the doors.

So far, the Friends have worked with staff to find out the true costs of the Bascom and Seven Trees sites. Looking at this budget cycle, the sites could be opened for half the budget year beginning 1/1/11. The monthly cost to maintain the closed buildings is \$26,150 while actually using them would cost \$101,000 each month.

The Friends group marched with others at a recent rally and spoke before our City Council. They are continuing to write letters and recruit members. They are consistent in sending the message that all facilities, not just ours, should be opened. By the time you read this, decisions may have been made, but it is never too late to join the *Friends of Bascom Library* in their work to make our local library the hub of community activity. Our community has worked for more than a decade to bring services here that other communities take for granted. We have paid the same taxes year after year even though we haven't had the benefit year after year. While the Friends of Bascom Library group will eventually work only on our site, they have been sending a clear message that all libraries, not just ours, should open.
